

Consumer Information - Closing Checklist

In an effort to avoid potential problems and delays, here are a few points to consider before your closing.

- Bring a Cashier's or Certified Check to the closing for the amounts you owe (not a personal check) payable to Fidelity National Title. If the amount is \$10,000 or over, it must be wired (Indiana Good Funds Law). Please contact your closing office for wiring instructions.
- Before the closing, contact your lender regarding any additional requirements that must be satisfied prior to the closing.
- If you have an existing mortgage(s), a current pay off letter(s) must be presented <u>prior</u> to closing. Contact your lender for instructions on how to obtain a current pay off statement(s).
- If you are going to be paying off credit card balances, the most current statements with full account numbers must be provided prior to the closing.
- If your property is a condominium, an assessment letter from your condo association or property management company must be provided <u>prior</u> to the closing.
- Bring to the closing two (2) forms of personal identification that include your picture and signature. A Primary and secondary ID are required. The following lists IDs which will be accepted:
